

Private Ministerial Membership Agreement

Stone's Throw Acres

This private agreement is between Stone's Throw Acres including Matt and Janice Stone (STA), and _____ (Member).

This private agreement gives STA Membership privileges to Member for the purpose of acquiring STA products, services, and/or attending events. The products, services, and/or events acquired by Member supports STA Ministry (Flourishing Ministries) which is actively bringing the nourishing word of salvation and nutrient dense food to all people.

Membership Fee

STA Membership fee is \$12 per year. STA encourages Member to join ShopYourFarm.com on-line market platform for the purpose of placing product, service, and/or event requests. If Member does join ShopYourFarm.com, Member will receive a reduction equivalent to the value of the ShopYourFarm.com (SYF) membership on their initial request. The reduction for being a member of SYF will be given in the same manner every year Member renews their SYF membership. This reduction is given to encourage the use of SYF as the means to place requests for products, services, and events.

Once STA Membership has been approved, Member will receive a copy of the agreement signed by both parties via email.

Membership fees are NOT refundable after STA Membership has been accepted by STA.

Term of Agreement

The agreement will remain in force for one year from the date this agreement was autographed by Member and STA. Either Member or STA may cancel at any time for any reason. Such notice must be provided in writing either via email or certified U.S. mail. In the event STA initiates the cancellation, Member will be provided reason for cancellation and opportunity to appeal the cancellation to STA.

Cancellation of Stone's Throw Acres Membership will remain in force until the anniversary date. If Member wishes to reinstate their cancelled STA Membership, a new STA Membership agreement must be autographed, and membership fee paid. Upon the completion of application review process, Member will be notified via email as to the acceptance or denial of application. If membership is denied, reason for denial will be provided.

STA Membership will be renewed annually upon the receipt of the annual membership fee. If membership renewal fee is received prior to or within 30 after their anniversary date, STA Membership will continue from the original anniversary date. If membership renewal fee is received more than 30 days after their anniversary date, Member is required to complete a new membership agreement and submit the annual membership fee. This application is subject to the same review process as the initial application.

Dispute

The value of physical rounds and coins is based on a fixed amount as established in the Confidential Product Guide. "Junk silver" coins and silver certificates will NOT be accepted except at their face value.

STA holds Members' information in confidence and will share with no one except when Member has authorized the disclosure. All information obtained by STA will only be used to communicate with Member.

Products and/or Services

STA offers a wide range of products, services, and events to STA Members only. See the Confidential Product Guide for a detailed description of products, services, and events offered along with shipping information.

Accepting Product and/or Service Requests

STA will send a product, service, and event request confirmation to Member via email by 10:00 pm central time. This could be extended to the next business day if there are complication with technology.

Confidentiality
